We held our monthly Committee meeting last week. We discussed, among other topics, the Winter Archives Corner, which deals with areas of cooperation between the 4 AA districts in DuPage County since the time these 4 districts were formed in the early 1980s. It includes reference to the annual DuPage County Open held in February. The Archives Corner will be posted soon on the District web site (if not done already). We encourage you to take a look.

For the Budget, we would like to keep to the same numbers as last year. Archives \$800 and Archivist \$500.

Our main topic was a discussion around Group Histories. We feel we have a lot of work to do regarding updating, verifying and maintaining our District 43 group histories.

A couple of areas we will be addressing

- 1) Verifying we have all the group histories within the district. New groups have formed, and some have closed. Our process for documenting new groups needs to firmed up as currently we get this information on a hap hazard basis from different sources.
- 2) During Covid, there were a lot of changes which have not been documented. To this end we would like to create and add a supplemental page to each group history to cover these changes. For instance, some groups met online, then became hybrid or stayed online only, or split from the original meeting to form new meeting. We currently have 80 groups within the district, so this will be quite a project and we'll be looking for some support from our group GSR's and committee members to help us in this endeavor.

We continue to actively collect and preserve pertinent information relating to the history of District 43. Old flyers, directories, and other AA related materials that you are thinking about throwing out may be useful to Archives and we will gladly accept them. Pictures of your meeting place, inside and outside, are also desired. Call the Archivist at 630-903-7626 or email Archives via the District website (archives@aa-nia-dist43.org) if you have anything that might fit the bill.

We'd also like to collect any relevant information from our service committees that goes beyond the monthly committee reports to help fill out the bigger picture of the service work done within our District. Examples could be committee meeting agendas; drafts/works in progress; correspondence with other districts, NIA20, and/or outside (non-AA) organizations; etc., but we'll leave particulars up to you who know best the work of your committee.

- On page 64, remove the sentence "It seems to control and punish people who are addicted to it" from the last paragraph.
- On page 9, remove the definition of "Addiction" from the Glossary section.
- On page 11, revise the sentence "Dr. Silkworth ran the Charles B. Towns Hospital for Drug and Alcohol Addictions in New York City during the 1930s."
 To read:
 - "Dr. Silkworth ran the Charles B. Towns Hospital for alcoholism and drug addiction in New York City during the 1930s."
- On page 14, revise the sentence "I help people recover from their alcohol and drug addictions"

To read:

"I help people recover from their alcoholism and drug addiction."

• "On page 139, revise the sentence "In one of these cities there is a well-known hospital for the treatment of alcohol and drug addiction."

To read:

"In one of these cities there is a well-known hospital for the treatment of alcoholism."
