In addition to our ongoing archiving efforts, we're continuing our deep dive into Group Histories.

We're in the final stages of preparing the "Group History COVID Supplement," which aims to gather information from District groups about their experiences and activities during the COVID-19 pandemic.

Many of the group's histories currently on file are due for review and updates to reflect changes that have occurred since they were originally documented. For instance, the Area Registrar lists District 43 as having 121 groups (64 active), whereas the District 43 Archives has 154 groups recorded, with 80 marked as active. Clearly, there's important work to be done—amongst other things, to reconcile these records.

We encourage all GSR or any committee person to review their group's current history (contact Archives for assistance) and help us ensure our records are as accurate and complete as possible.

We continue to actively collect and preserve pertinent information relating to the history of District 43. Old flyers, directories, and other AA related materials that you are thinking about throwing out may be useful to Archives and we will gladly accept them. Pictures of your meeting place, inside and outside, are also desired. Call the Archivist at 630-903-7626 or email Archives via the District website ([archives@aa-nia-dist43.org](mailto:archives@aa-nia-dist43.org)) if you have anything that might fit the bill.

We'd also like to collect any relevant information from our service committees that goes beyond the monthly committee reports to help fill out the bigger picture of the service work done within our District. Examples could be committee meeting agendas; drafts/works in progress; correspondence with other districts, NIA20, and/or outside (non-AA)

organizations; but we'll leave particulars up to you who know best the work of your committee.

The following information was shared with Literature chairs from GSO:

The Literature Committee Workbook was released mid-September 2024 and has been very well received. The initial printing sold out in 2 months with solid engagement through the [aa.org](http://aa.org) website as well. The workbook is back in stock and available for Literature Committee chairs and interested members

The 2024-2026 A.A. Service Manual/Twelve Concepts for World Services went on sale in early December. Between December 6, 2024, and January 2, 2025, more than 6,200 copies were sold. The *A.A. Service Manual* is another resource which some members find particularly useful in electronic format.

The *Plain Language Big Book: A Tool for Reading Alcoholics Anonymous* went on sale on November 1, 2024. 71,749 copies were sold between November 1 and November 18. A second printing was placed on November 24, 2024; more information can be found within this letter from the General Service Board Chair: PLBB Second Printing. The *Plain Language Big Book: A Tool for Reading Alcoholics Anonymous* is also available as an e-book and is accessible on Corrections tablets throughout the United States.

**Current Projects**

- Fifth Edition Big Book (*Alcoholics Anonymous*): The drafting of expanding content in Appendix III: "The Medical View on A.A." and Appendix V: "The Religious View on A.A."

has begun. The subcommittee is finalizing its selections of personal stories for review by the trustees' Literature Committee and the Conference Committee on Literature.

- Development of a Fourth Edition Big Book *Alcohólicos Anónimos* (Spanish): The creation of the draft Fourth Edition *Alcohólicos Anónimos* is being guided by an Appointed Committee Member (ACM) of the trustees' Literature Committee and a working group of Hispanic A.A. members. The working group recently added a new member from Quebec and is looking to add an additional member from Puerto Rico. The working group is proceeding to the next stage in selecting personal stories and continues to receive newly re-translated chapters.
- Update of the pamphlet "A.A. for the Native North American": The working group, comprised entirely of indigenous A.A. members, has completed a selection of 15 personal stories, provided a new introduction, and selected new cover art developed by an indigenous artist. "We shall be interested to hear from those who are getting results from this book, particularly from those who have commenced work with other alcoholics."
- Update of the pamphlet "Do You Think You're Different": The subcommittee has completed the review of personal stories. Work will continue on the project with a progress report being delivered to the General Service Conference.
- Update of the pamphlet "Questions and Answers on Sponsorship": The subcommittee completed a working draft of the requested updates.
- Update of the pamphlet "Twelve Steps Illustrated": Revised illustrations were completed, supported by the trustees' Literature Committee, and forwarded as draft material to the General Service Conference.
- Update of the pamphlet "The Twelve Concepts Illustrated" video animation: The translation of narration voiceover and visual text into French and Spanish has been completed. The English video is currently under review by members of the trustees' Literature Committee.

I have since deleted both these phantom meetings.
